3- Course General Objectives:

The administrative law course aims to define the set of rules that govern public administration, in light of the development of the tasks of the modern state, and its

burdens, as it has become unable to carry out these modern and multiple tasks and burdens, and the state's interest has become more and more focused on its intervention in areas that were the preserve of individuals, or Activities that were limited to individual events. The development that affected the role of the state, and its interference in all aspects of life, has been affected by another development, which is its submission to the law and respect for legal legitimacy.

The executive authority, which carries out the administrative function, enjoys several privileges, as it represents the public interest. However, the administration's exercise of its administrative activity and function must be in accordance with precise legal controls, and these restrictions and controls are in fact the controls and rules of administrative law. And among the individuals who deal with it when exercising its activity as a public authority, it has contributed to enhancing the importance of administrative law.

And the administrative law that organizes the administrative authorities in the state, and governs their activities carried out by them, has made an effective contribution to achieving a balance between the privileges granted to the administration, and preserving the rights and freedoms of individuals.

Thus, the study of administrative law requires familiarity with its principles, rules, and follow-up of its development, and this can only be achieved by keeping pace with the provisions of the administrative judiciary, because administrative law is at the origin of its inception a judicial law, and its principles and theories are extracted from judicial rulings.
